DELAWARE ARTIFICIAL INTELLIGENCE COMMISSION ANNUAL REPORT 2025

The Delaware Artificial Intelligence (“A.I.”) Commission (“Commission”) has been productive in 2025 and is making great strides to evaluate the opportunities and challenges the emerging technology brings to Delaware.

The Commission met four times in 2025 – January 24, 2025; July 25, 2025; October 24, 2025; and December 19, 2025. The Commission has created three subcommittees to assist in its mission: the Delaware AI Training Subcommittee; the AI Models Subcommittee; and the Agentic Artificial Intelligence Regulatory Sandbox Subcommittee (“Sandbox Subcommittee”).

The Training Subcommittee, chaired by Commissioner and Delaware CIO Gregory Lane, is focused on empowering Delaware’s State employees and public using cutting edge AI education, ethical implementation, and continuous innovation. The goal is to enhance the delivery of public services, support, informed decision making, mitigate risks, and strengthen public trust.

The AI Models subcommittee is chaired by Commission Vice Chair and University of Delaware Professor Sunita Chandrasekaran. The subcommittee is studying the possibility of creating a A.I. Model that would be for the use of Delawareans. The purpose of this would be to: ensure/enable control over Delawareans’ data by minimizing reliance on third-party vendors; prioritize using data to enhance Delaware’s own models and capabilities; foster innovation by building tailored solutions that fit Delaware’s unique needs; invest in technologies that provide transparency and tangible value rather than opaque high cost subscriptions; choose systems that offer learning opportunities and clear insights into data handling and processing; and create an infrastructure that will enable/facilitate building “customized” AI models tailored to Delaware’s needs.

The Sandbox Subcommittee was formed by the Commission following the passage by the Delaware General Assembly of House Joint Resolution 7 (“HJR 7”). Chaired by Commissioner Patrick Callahan, the subcommittee is actively working towards a draft regulatory framework that would create a regulatory sandbox that would test and evaluate agentic artificial intelligence and its application to corporate governance. At its most recent meeting, the Sandbox Subcommittee received an update from Delaware Secretary of State Charuni Patibanda-Sanchez on the work of a group she has formed to investigate a potential structure for a regulatory sandbox. The subcommittee in coming weeks will work to refine those ideas into potential draft legislation.

The Commission also welcomed a new member – Brandywine High School student Aiden Gamble. Mr. Gamble is a nonvoting member. He joined the Commission following the General Assembly's passage of Houses Bill 33 to include a high school student as part of the Commission to ensure the Commission is including the state's youngest generation in its work.

The Commission also reviewed the Delaware's Generative Artificial Intelligence Policy to guide the proper use of artificial intelligence by State of Delaware employees.

In 2026, the Commission is scheduled to meet on Friday, January 23; Friday, April 24; Friday, July 24; and Friday, Oct. 23. The meetings are held from 12:30 to 2 p.m.

By way of background, the Commission was created by House Bill 333, an Act to Amend Title 29 of the Delaware Code Relating to the Artificial Intelligence Commission ("Act"). The House of Representatives and the Senate approved the Act unanimously on May 7, 2024, and June 20, 2024, respectively. Governor Carney signed the Act on July 17, 2024
